The National Professional Standards for Teachers sets out to NEP 2020 aiming for the highest quality education for all learners. National Professional Standards for Teachers ensures that all students at all levels of school education are taught by passionate, motivated highly qualified, professionally trained and well equipped teachers. National Professional Standards for Teachers also lays down the conditions of service of teachers and the means by which they will be appointed, transferred and evaluated in addition, National Professional Standards for Teachers described the Academic Qualifications, Professional Competence, and Non Teaching Responsibilities that will ensure excel teaching in schools. To bring poise to this system, integrity, credibility and quality must be restored prior. NEP 2020 aims to increase the gross enrollment ratio in higher education including vocational education. National Educational policy 2020 focuses on three pillars- Quality Teacher Education, Quality in Teaching and Quality Assurance. To ensure continual learning it has been crafted consistent with the needs of citizen as a demand for knowledge in society and economy called for a need to acquire new skills on regular basis. Quality Assurance National Education Policy 2020 has proposed 4 year B.Ed. program in which all teacher education institutions will be converted into multidisciplinary degree institutions. In these institutions 4 years integrated B.Ed. program would be very innovative. National Educational Policy 2020 also declared that for becoming a teacher in a school it is mandatory to have 4 years integrated B.Ed. course. The universities should have an objective to establish educational departments collaborate with other different disciplinary department. Presently teacher education institutions have 2 year B.Ed. program which can be shifted to multidisciplinary institute by providing 4 years integrated teacher education. Till 2030, 4 year integrated B.Ed. program will be mandatory criteria for a school teacher. Simultaneously, higher education colleges will conduct the exam by National Testing Agency (NTA) to take admission in teacher education program. Students need to pass a subject aptitude test for the same. These institutions will provide the trained and skilled teachers to the country. National Professional Standard provides a framework that allows teachers to reflect on their own practice, enabling them to identify area of their own professional development during their careers. Professional standard can be used in examining how the standards are implemented and what nature of change they exert.

CONCLUSION

National Educational Policy aims to set the National Professional Standards for Teachers to determine all aspect of teacher career management, effort for professional development, salary
